They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ▪ <i>GenTrust affiliates include GT Lifestyle Services ("GTLS"), Catenary Alternatives Asset Management ("CAAM"), and AIRIA Investment Technology ("AIRIA")</i>
Non-affiliates	<p>Companies not related by common ownership and control. They can be financial or nonfinancial companies.</p> <ul style="list-style-type: none"> ▪ <i>We do not share with non-affiliates so that they can market to you.</i>
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or service to you.</p> <ul style="list-style-type: none"> ▪ <i>We do not jointly market.</i>
